REFERRALS

As your primary-care provider, we will assist you in coordinating your medical care. Please consult us about any healthrelated question you may have. In that way, we can recommend any necessary medical treatment &/or follow-up care.

If you have been referred to us for specialty care by another physician, please be sure to have prior-authorization (if required by your insurance) for the scheduled consultation.

Please note: you do not need prior authorization for prenatal care, gynecologic exams & annual ophthalmologic eye exams (if you have diabetes). Depending on your insurance, however, your choice may be limited to a group of contracted providers. THIRD PAGE

OFFICE VISITS & URGENT-CARE

If you are a new patient, please bring a current list of medications with you at your first visit. As office policy dictates that we do not accept walkins, please remember to always call ahead of time to schedule an appointment. Similarly, if you have a need which requires same-day medical attention, always call! We understand such situations may arise & in most cases, will readily accommodate your request.

TELEPHONE CALLS

We encourage you to call us if you have any questions or concerns. Please note that calls considered "non-urgent" will be returned within one business day.

APPOINTMENT CANCELLATIONS

Cancellations or changes must be made at least 24 hours prior to your scheduled appointment in order to avoid a \$30 administrative fee.

PRESCRIPTION REFILLS

Please ask your pharmacist to fax requests for prescription refills at least 5 days prior to the completion of chronically used medications. You may also call us directly but please do not wait until the last day of available medication to call the office.

TEST RESULTS

It is our policy to confirm follow-up visits for all patients who have had tests ordered. Under no circumstances will test results be given over the phone as this violates federal guidelines that safeguard the confidentiality of patients' medical information. One option, however, to scheduling an office visit is to request an online consult through LASCMA's account on the Medem Network at <u>www.lascma.medem.com</u>. Registration is free, but a \$30 charge does apply for all non-urgent medical questions or requests for test results (...in lieu of the standard co-pay and the need to return for an FOURTH PAGE

office visit.) Keep in mind, you may still be encouraged to schedule a follow-up exam with your doctor.

PAYMENT POLICY

As required by health plans, we will collect all co-pays & deductibles at the time of service. It is important that you submit your most current health insurance information prior to your visit so that we can accurately determine the amount for which you will be responsible.

For your convenience, we accept cash, checks & credit cards (Visa, MasterCard & Discover.) Clients may use credit cards to pay any balance, office visit copay or uncovered procedure charge and with no restriction on the minimal amount submitted. Available both on-line and in the office, a \$1.50 surcharge does apply to credit card transactions. Be assured that all on-line transactions are safe & secure, involving the use of the latest in SSL encryption technologies.

WEB-BASED & ON-LINE SERVICES

At this time, clients can quickly complete various medical & insurance up-date forms by using any computer with an internet connection. Links to a variety of office forms can be found in the "FORMS" section of our website at *http://www.lascma.com.* Again, all forms are transmitted to our database using an industry standard, SSL encrypted server.
